
## GENERAL IMAGE REQUIREMENTS

#### **ALL IMAGES MUST BE:**

- portrait layout
- with plain background Light Grey (apparel), White (product)
- in JPEG format
- minimum **762pixel x 1100pixel** and **300dpi** in image size and resolution
  - this is to ensure image is not pixelated
- Ratio 0.69:1
- Size of file: 2MB max/ per file or maximum 2000pixels x 2000pixels
- clear and not blur/pixelated
  - products are presented as the main focus of the image
  - products are presented in a neat and tidy manner
- does not contain any other brand's logo/name
- no watermarks
- \* Images that fail to meet these requirements will automatically be suspended

## Background Colour for Products – Required Standard

- Main image background must be in shades of grey
- Dark tones will be rejected (refer to image below)







# LIGHTING & COLOR – REQUIRED STANDARD

Studio lighting is recommended in order for product and model to be presented professionally








- Product and model is bright and attractive
- Overall image does not look dull.
- Model's skin tone looks healthy & radiant

Main image of product should be presented in a tidy manner on a white background.

- Product presented on a plain white background in a neat and tidy manner
- Product on a plain white background presented in a neat and tidy manner

# LIGHTING & COLOR – REJECT

Poorly lit images do not appeal to customers



- $(\times)$
- Color tone is over-saturated
- Looks over-edited and unnatural



Strong background color



 Dull color and lack of light makes the overall image unappealing



 Image looks like it is being shot using a mobile phone camera/low quality camera.

# BUNDLE – REQUIRED STANDARD (MIN 1 IMAGE PER SET)

Main image of product should be presented in a tidy manner on a white background.



# BEAUTY PRODUCTS – REQUIRED STANDARD

#### Main image presentation and angle of glasses that are NOT acceptable



- Cover of product /bottle can be shown next to the actual product
- 200px from the bottom




- Box/Packaging can be shown next to the product
- 200pc from the bottom

# LIPSTICK- PERFECT WAY TO SHOWCASE YOUR PRODUCT

Main image of product should be presented in a tidy manner on a white background.

#### Example:



 First image should be frontal view of product presented in a tidy manner (MUST)  Second image shows what it is like when apply on lip (if any)

Detail view to see the actual colour on the lipstick (if any)
