

### STATEMENT OF ACCOUNT

#### Step on how to get the SOA from Seller Center.

- 1. Log in to your Seller Center Account
- 2. Go to Reports then click Account State ments
- 3. Under Account Statements tab, choose which period you want to extract.
- 4. You may extract the charges by clicking "Download All Transactions" or "Download Sales Report" to get the total sales for the month below.
- 5. From the excel file, you may filter the "Transaction Type" (Column B) to get the specific order number.

SOA Issuance, ZALORA on a monthly basis will provide each Marketplace Seller of Statement of Account (SOA): every 10<sup>th</sup> business day of the month via Seller Center reports.

  - Debit of other revenues
  - Refund on Commission and Discount
  - Shipping Fee rebate (if applicable)
- G. Payout (Final sales of the month)
- **H.** Payment Status

#### • <u>Timeline</u>

- eSOA release from Seller Center: every 10th business days of the month.
- Disputes: Seller must review the SOA and communicate any discrepancy within 5 working days to Seller Center Help Desk.
- Seller shall reply and confirm the revised SOA if approved for payment within 2 working days.
- Payout: count starts on 1st day of the month.
- If payout falls on a holiday or weekend, payout will be on the earliest Friday before the payout date.
